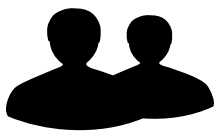

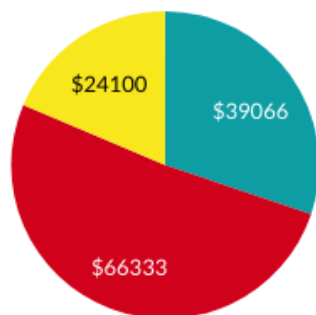
# Bay Mills Child Development Center

### Recycled Materials

- Pharmaceutical waste (collected year-round at Health Center): 50 lbs
- Used tires (seasonally collected): 16,361lbs
- Household hazardous waste (including light bulbs): 6,128 lbs
- Electronic waste (bi-annually): 11,700lbs
- Beach trash (May-September): 330 lbs
- Other waste removal from local streams and wetlands: 8120 lbs (double the amount from 2021)

### Projects included:

- Disinfection of boats
- Wetland monitoring
- Removed nine bags of invasive Japanese Knotweed, 38 bags of invasive purple loosestrife & 270 bags of spotted knapweed
- Monitoring Streams & Lakes (26 sites)
- Monitoring Wild Rice at four sites
- Updated the solid waste management plan for BMIC and did the Green Community Assessment
- Planted 1,000 lbs of wild rice

# 2022 Economic Impact Report

## GRANT FUNDING RECEIVED

· Bay Mills Indian Community has a total of 175 active grants worth around \$70 million. (Approximately a total of \$27 million of grant funds were expended in 2022)

· 61 Grants were awarded/rewarded in 2022 for around \$11 million. This includes 25 new grants.

### A sample of these grants includes:

· EV Chargers - \$100,000 TOTAL - (\$29,000 from BIA; \$72,000 from State of MI)

– Installation of one (1) DC Fast Charger and four (4) Level 2 Chargers at Bay Mills Resort & Casino

· Indian Community Development Block Grant (ICDBG) – American Rescue Plan (ARP); Expansion from U.S Department of Housing and Urban Development - \$1 Million

– This is to renovation the entrance and reception area for the old health center / new admin building. This was started in 2021.

Ongoing project.

· Indian Community Development Block Grant : Boys & Girls Club Expansion from U.S Department of Housing and Urban Development

- \$700,000

– This is to expand the new club building by 1875 square feet.

· Local Assistance and Tribal Consistency Fund (LATCF), from the US Dept. of Treasury- \$743,450.

– Funding will be used to strengthen information technology systems for Bay Mills Indian Community . Will be used to help with IT for infrastructure and technology.

· Solar Accelerator Fund from GRID Alternatives - \$200,000

– To add solar power to Justice Center and Senior Center

· Comprehensive Services for Behavioral Health - Tribal Behavioral Health 2023 - \$250,000

– Funding for Bay Mills Behavioral Health to assist, monitor, and treat clients by providing eastern medicine access within the facility.

· Tribal Court Expansion – Supplemental - \$415,0000

– Funding for the completion of the Bay Mills Tribal Court Building.

· Coordinated Tribal Assistance Solicitation (CTAS); for Purpose Area 3 – Enhancing the Healing the Wellness Court - \$898,556

· Prevent Elder and Vulnerable Adult Abuse

– Funding to help address elders with home cleaning and hoarding.

· Native American Business Development Institute (NABDI) Septic Services Feasibility Study - \$75,000

– Feasibility Study to Assess Economic Diversification Opportunities for Septic Services

· Michigan Arts and Cultural Council - \$2,000

– Mural for the Cultural Center.

· David Rockefeller Fund - \$50,000

– To help with Line 5 work.

· Great Lakes Fish and Wildlife Commission – Youth Services - \$10,300

– To support youth worker placement and treaty rights workshops throughout Bay Mills.
